DEFECTIVE EQUIPMENT VIOLATIONS

YOU MAY SHOW THE REPAIR AT THE POLICE STATION AND BRING AN OFFICERS SIGNATURE ON THE TICKET TO THE COURT AT THE APPEARANCE DATE/WITHIN 10 DAYS, AND THE FINE WILL BE WAIVED

NO VALID REGISTRATION ON PERSON VIOLATIONS

YOU MAY SHOW PROOF THAT THE REGISTRATION WAS VALID AT THE TIME THE VIOLATION WAS ISSUED TO THE POLICE DEPARTMENT, THEY WILL SIGN OFF ON THE TICKET AND YOU MUST BRING THE SIGNED OFF TICKET TO THE COURT WITHIN 10 DAYS OF ISSUANCE.

NO PROOF OF INSURANCE VIOLATIONS

THE FINE IS WAIVED UPON PROOF THAT THE VEHICLE WAS INSURED AT THE TIME THE TICKET WAS ISSUED. PROOF OF INSURANCE MUST BE BROUGHT TO THE COURT WITHIN 10 DAYS FROM THE DATE OF THE VIOLATION. A \$25 COST WILL BE ASSESSED THAT CANNOT BE WAIVED.

If your license was valid at the time the violation was issued, you can take your license to any law enforcement agency to have an officer sign off on the violation and return to the court on or before your hearing date and the fine will be waived.

THE COURT WILL AUTOMATICALLY MAIL YOU AN ARRAIGNMENT DATE WITHIN 7 DAYS FROM THE DATE YOU RECEIVE THE TICKET. IF YOUR ADDRESS IS NOT CORRECT ON THE TICKET PLEASE CONTACT THE COURT. IF YOU DO NOT RECEIVE YOUR COURT DATE IN 7 DAYS PLEASE CONTACT THE COURT.
